Variations of the company's governing bodies – The legal representatives of the company's governing bodies, by the deadline of thirty days from the supervened change of the governing or managerial set-up of the company, are obliged to transmit to the chief magistrate who has seen to issuance of the corporate accountability report or registration in the white list copy of the documents attesting the supervened change regarding the addressees of the anti-mafia controls. Breach of the said obligation is punished by the pecuniary administrative sanction (from EUR 20.000 to 60.000) laid down in Article 86 (4) of Legislative Decree No. 159/2011.
